Non-Food Vendors - \$300.00

You will be required to bring your own tables and setups. You may bring your own tents, which should not exceed 10'x10' for the vendor area.

Food vendors - \$450.00

You will be required to submit a fire permit (enclosed within) and include a separate check in the amount of \$42.00 made payable to "Monmouth County Fire Marshal".

**ALL VENDORS ARE PROHIBITED FROM SELLING ANY TYPE OF BEVERAGE.
ALL BEVERAGES WILL BE SOLD BY MONMOUTH PARK RACETRACK.**

A map of your location will be emailed to you one week prior to the festival. Set-up time starts at 8:00 A.M. and must be completed by 11:00 A.M. No set-ups will be allowed after 11:30 A.M. Vending hours are from 11:30 A.M. to 7 P.M.
